



Documenting the process by which government and controlling majorities have grown increasingly powerful and tyrannical, Bertrand de Jouvenel demonstrates how democracies have failed to limit the powers of government. This development Jouvenel traces all the way back to the days of royal absolutism, which established large administrative bureaucracies and thuse laid the foundation of the modern omnipotent state.

On Power is an important work, which Professor Angelo M. Petroni of the Luigi Einaudi Center for Research in Torino, Italy, has said is "simply a book that no serious scholar of political science or political philosophy can afford to ignore."

Bertrand de Jouvenel was born in Paris in 1903; he travelled widely, becoming an astute observer of British and American institutions. Later in life, he was an author and teacher, first publishing **On Power** in



1945. Jouvenel died in 1987. Among his other books, besides The Ethics of Redistribution, are Sovereignty: An Inquiry into the Political Good (1957) and The Pure Theory of Politics (1963).

Althusius' Politics has been said to be "one of the most influential books of political theory published in the seventeenth century." It went through at least six editions in Germany from 1603 to 1654 and was extensively cited by thinkers of the day. But, for reasons which are not clear, the work fell into obscurity and was not rediscovered until the late nineteenth century. Since then, Althusius' Politics has been recognized as an extraordinary contribution to Western political thought whose value far transcends the political realities of the seventeenth century.

It is Althusius' theory of federalism that makes the **Politics** especially timely today. The theory is based on an ascending scale of authority, beginning with the family, and upward through all voluntary public and private associations to the "supreme magistrate." Each association can act only with the consent of those beneath it in the scale of authority. It has been said, therefore, that Althusius' concept of federalism is unique in that it limits the powers of central government by balancing its powers with the collective powers of those public and private institutions and associations which exist between the state and the individual.

Unlike many modern theorists, Althusius understands the fundamental importance of mediating institutions and associations in securing limited government and so preserving individual liberties in the social and political order. The **Politics** also clarifies the proper relationship between freedom and responsibility in a federal republic.

The **Politics** combines the best of ancient and medieval political philosophy with that of Reformation and modern theory. Thus Althusius' thought is considered a bridge between the political wisdom of the ancients and the moderns. This is a carefully abridged translation of Althusius' work—thoughtful, scholarly, and highly readable.



JOHANNES ALTHUSIUS

Johannes Althusius (1557-1638) was a German political and legal philosopher. He served as a municipal magistrate—the Syndic of Emden (now Germany)—for more than thirty-four years.



This description by Wilhelm von Humboldt of his purpose in writing The Limits of State Action animates John Stuart Mill's On Liberty and serves as its famous epigraph. Seldom has a book spoken so dramatically to another writer. Many commentators even believe that Humboldt's discussion of issues of freedom and individual responsibility possesses greater clarity and directness than Mill's.

The Limits of State Action, by "Germany's greatest philosopher of freedom," as F. A. Hayek called

him, has an exuberance and attention to principle that makes it a valuable introduction to classical liberal political thought. It is also crucial for an understanding of liberalism as it developed in Europe at the turn of the nineteenth century. Humboldt explores the role that liberty plays in individual development, discusses criteria for permitting the state to limit individual actions, and suggests ways of confining the state to its proper bounds. In so doing, he uniquely combines the ancient concern for human excellence and the modern concern for what has come to be known as negative liberty.



John Taylor of Caroline (1753-1824) was one of the foremost philosophers of the states' rights Jeffersonians of the early national period. In keeping with his lifelong mission as a "minority man," John Taylor wrote Tyranny Unmasked not only to assault the protective tariff and the mercantilist policies of the times, but also "to examine general principles in relation to commerce, political economy, and a free government." Originally published in 1822, it is the only major work of Taylor's that has never been reprinted.

As an early discussion of the principles of governmental power and their relationship to political economy and liberty, **Tyranny Unmasked** is an important primary source in the study of American history and

political thought.
